**REQUESTED ACTION:** The Zoning Administrator will consider:

- 1. Pursuant to Section 12.24-M, of Los Angeles Municipal Code, Approval of Plans to review compliance with Conditions of Approval per condition No. 25 of Case No. ZA-2013-3011(CUB) for the continued off-site sale of a full line of alcoholic beverages in conjunction with an existing retail/pharmacy with 24 hour daily operation and modification of condition No. 24 to extend the term grant.
- 2. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of CEQA.

The purpose of this hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.
