PROJECT LOCATION:

1533 N. Vista Street

PROPOSED PROJECT:

The demolition of a single family home and detached garage, and the construction, use, and maintenance of a new 4-story, 4-unit residential condominium over one subterranean parking level, providing 9 automobile parking spaces (includes 1 guest space) and 6 bicycle parking spaces, constructed to a height of 45 feet on an approximately 4,928 gross square foot site in the R3-1 Zone.

REQUESTED ACTION:

The Deputy Advisory Agency will consider:

- Pursuant to the Los Angeles Municipal Code Section 17.50, Parcel Map No. AA-2015-3932-PMLA-CN to permit a one-lot subdivision for the construction of a 4-unit residential condominium building on a 4,928 gross square foot site; and
- 2. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall, therefore, be exempt from the provisions of CEQA.
