Sunset Boulevard</u>: DIR-2015-4657-DRB-SPP, ENV-2015-4658-CE; A project to remodel the exterior and the interior with refreshed landscaping on an 11,930 square foot site with an existing 2,034 square-foot, free-standing, single-story retail building. There are seven on-site parking spaces. The project also includes the addition of an 833 square-foot outdoor deck, and signage. The proposed new use is a vegan market with prepared, take-out food service. The project location is on the west side of Sunset Boulevard approximately three blocks north of Pacific Coast Highway.
- b. <u>17373 17383 W. Sunset Boulevard</u>: DIR-2015-4483-DRB-SPP; ENV-2015-4484-CE; The Pacific Palisades Design Review Board will continue hearing this project from the public meeting of February 24, and March 9, 2016. The project is the renovation of the exterior and exposed interiors of an existing 93,900 square foot, three-story, office complex on an irregular 75,100 square foot lot.

Individual testimony within the public comment period shall be limited to three (3) minutes per person and up to ten (10) minutes per subject. However, the DRB chairperson has the discretion to modify the time allotted on each subject, to each speaker and the number of speakers per subject. Items may be called in any order at the discretion of the DRB chairperson. EVERY PERSON WISHING TO ADDRESS THE BOARD DURING THE MEETING MUST COMPLETE A SPEAKER'S CARD AND SUBMIT IT TO THE CITY PLANNING STAFF.
