REQUESTED ACTION: The Zoning Administrator will consider:

- 1. Pursuant to Section 12.24-W 1, of the Los Angeles Municipal Code, a Master Conditional Use Permit to allow the sale and dispensation of a full line of alcoholic beverages for on-site consumption in conjunction with the change of use from a portion of an existing industrial/commercial building to a 2,806 sq. ft. bar/lounge at the basement floor; a 9,675 sq. ft. restaurant and a 4,289 sq. ft. restaurant with a 2,690 sq. ft. outdoor uncovered patio at the ground level; and a 3,420 sq. ft. bar/lounge at the penthouse floor with a 5,260 sq. ft. outdoor uncovered roof deck with hours of operation ranging from 6:00 a.m. to 2:00 a.m. daily.
- 2. Pursuant to Section 21082.1(c)(3) of the California Public Resources Code, adopt the Mitigated Negative Declaration (MND) for the above referenced project.
