REQUESTED ACTION: The Zoning Administrator will consider:

- 1. Pursuant to Section 12.27 of the Code, a Variance to permit a lot coverage of 59% in lieu of the maximum lot coverage of 40% allowed by Section 12.21 C,10(e); and 2) Pursuant to the provisions of Section 12.28 of the Los Angeles Municipal Code, a Zoning Administrator's Adjustment to permit a side yard of 2 feet and 1-foot along the south and east property lines, respectively, in lieu of the 8-foot side yard required, and permit a rear yard of 9 feet 8 inches in lieu of the 15-foot rear yard required by Section 12.21,C-10, all in conjunction with the proposed demolition of an existing deck and jacuzzi and the construction of a new 625 square-foot deck with a 679 square-foot pool and spa, attached to an existing single-family residence on a 4,901 square-foot lot in the R1-1 Zone within a Hillside area.
- 2. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of CEQA.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

Exhaustion Of Administrative Remedies: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.

<u>Advice To Public</u>: The exact time this report will be considered during the meeting is uncertain since there may be several other items on the agenda.
