REQUESTED ACTION: The Zoning Administrator will consider:

- 1. A Coastal Development Permit, pursuant to the provisions of Section 12.20.2 of the Los Angeles Municipal Code, for the proposed demolition of an existing duplex and the construction of a single-family dwelling on a 2,698 square-foot lot zoned RD1.5-1, located within the single-jurisdiction area of the California Coastal Zone; 2) Pursuant to Section 12.28 of the Code, a Zoning Administrator's Adjustment to permit to allow a 7-foot 2-inch front yard in lieu of the 15-foot front yard required by Section 12.09.1-B; 3) Pursuant to Section 11.5.7 of the Code, a Project Permit Compliance from the Venice Coastal Zone Specific Plan; and 4) A Mello Determination.
- 2. Pursuant to Section 21082.1(c)(3) of the California Public Resources Code, adopt the Mitigated Negative Declaration (MND) for the above referenced project.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

Exhaustion Of Administrative Remedies: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
