**REQUESTED ACTION:** The Zoning Administrator will consider:

- 1. Pursuant to the provisions of Section 12.20.2 of the Los Angeles Municipal Code, a Coastal Development Permit for the construction of five retaining walls, a funicular, and a 299 square-foot addition to an existing single-family dwelling; pursuant to the provisions of Section 12.24,X-26 of the Los Angeles Municipal Code, Zoning Administrator's Determination to permit the construction, use and maintenance of five retaining walls maximum 12 feet in height, in lieu of two walls not to exceed 10 feet in height, all within the dual-jurisdiction area of the California Coastal Zone. (Zone Variance and Zoning Administrator's Adjustment requests withdrawn by applicant).
- 2. Pursuant to Section 21082.1(c)(3) of the California Public Resources Code, adopt the Mitigated Negative Declaration (MND) for the above referenced project.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

**Exhaustion Of Administrative Remedies:** If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
