**PROPOSED** The project involves the sale and dispensing of a full line of alcoholic beverages for on-site consumption in conjunction with a 2,300 square-foot restaurant accommodating 36 interior seats and 20 patio seats with hours of operation from 10:00 a.m. to 2:00 a.m., seven days a week.

# REQUESTED ACTIONS:

- The Zoning Administrator will consider the following:
- 1) Pursuant to Los Angeles Municipal Code Section 12.24-W,1, a Conditional Use to allow the sale and dispensing of a full line of alcoholic beverages for on-site consumption in conjunction with a restaurant within an existing building in the C2-1VL Zone;

- 2) Pursuant to Los Angeles Municipal Code Section 12.24-W,27, a Conditional Use to allow hours of operation exceeding the maximum permitted hours of 7:00 a.m. to 11:00 p.m. at a mini-shopping center; and
- 3) Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall, therefore, be exempt from the provisions of CEQA.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

**EXHAUSTION OF ADMINISTRATIVE REMEDIES**: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record.
