PROJECT LOCATION: 5842 West Carlton Way

PROPOSED PROJECT: Construction, use, and maintenance of a new five-story, 21-unit (3 set aside as affordable units) residential condominium with two levels of subterranean parking, and will be providing 31 automobile parking spaces and 23 bicycle parking spaces in the [Q]R4-1VL Zone.

REQUESTED ACTION: The Deputy Advisory Agency will consider:

1. Pursuant to the Los Angeles Municipal Code Section (LAMC) 17.03, Vesting Tentative Tract Map No. 73332-CN for the construction of a 21-unit residential condominium with 31 automobile parking spaces, 23 bicycle parking spaces, on a 8,754 net square-foot site in the [Q]R4-1VL Zone.
2. Pursuant to Section 21082.1(c)(3) of the California Public resources Code, adopt the

Mitigated Negative Declaration (ENV-2015-1276-MND) for the above referenced project.

3. Pursuant to Sections 21081.6 and 15097, the adoption of a Mitigation Monitoring Program for ENV-2015-1276-MND.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

EXHAUSTION OF ADMINISTRATIVE REMEDIES: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
