REQUESTED **ACTION:**

The Deputy Advisory Agency shall consider:

- Pursuant to Sections 21082.1(c)(3) and 21081.6 of the California Public Resources Code, consideration of the **Mitigated Negative Declaration** (MND) for the above referenced project.
- 2. Adoption of the **Mitigation Monitoring Program** (MMP) prepared for ENV-2014-4787-MND for the above referenced project.
- 3. Pursuant to Section 17.03 of the Los Angeles Municipal Code (LAMC) consideration of a **Tentative Tract Map** for a small lot subdivision.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.
