**REQUESTED ACTION:** The Zoning Administrator will consider:

1. Pursuant to the provisions of Section 12.27-B of the Los Angeles Municipal Code, Variances from 1) Section 12.17.5-B to allow the change of use of an approximately 6,240 square-foot storage and paint shop to an automotive repair use, 2) Section 12.21-A,4(x) to permit 10 on-site parking spaces in lieu of the required 40 parking spaces. 3) Section 14.4.10-C,1 to permit a sign less than 5 feet from an interior property line, and 4) Section 14.4.10-A,5 to permit a total of 1,972 square feet of wall signage in lieu of the maximum square feet otherwise allowed, in the MR-1VL Zone.
2. Pursuant to Section 21082.1(c)(3) of the California Public Resources Code, adopt the Mitigated Negative Declaration (MND) for the above referenced project.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

**Exhaustion Of Administrative Remedies:** If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.

**Advice to Public:** The exact time this report will be considered during the meeting is uncertain since there may be several other items on the agenda.
