Pursuant to Section 12.26-K of the Los Angeles Municipal Code, a Director of Planning Determination as to whether the Department of Building and Safety erred or abused its discretion in issuing Building Permit No. 15014-20000-02589 for the remodel and addition to an existing one-story single-family dwelling, Building Permit No. 15030-20000-04520 to remove the existing swimming pool and Building Permit No. 15047-20000-01583 to build a new swimming pool and spa on property located in the R1-1-RIO Zone.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision

maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.
