PROPOSED PROJECT:

The project is for a new convenience store (7-Eleven) within a vacant tenant space at an existing commercial corner/mini-shopping center development. The project proposes operating hours beyond what is permitted under the provisions of the Commercial Corner regulations in conjunction operation of a 2,472 square-foot, 24-hour 7-Eleven store in the C2-1 Zone. Only tenant improvements are proposed.

## REQUESTED ACTION:

- 1. Pursuant to Los Angeles Municipal Code Section 12.24-W,27, a Conditional Use to allow hours of operation exceeding the maximum permitted hours of 7:00 a.m. to 11:00 p.m. at a mini shopping center/commercial corner development;
- 2. Pursuant to the Los Angeles Municipal Code Section 12.24-W,27, a Conditional Use to allow the following deviation from Section 12,22-A,23:

- a. From 12.22-A23(a)(6)(i) to permit two new projecting signs;
- Pursuant to Section 21082.1 of the California Public Resources Code, the Zoning Administrator will consider adopting the Mitigated Negative Declaration, (ENV-2015-4570-MND) prepared for the proposed project.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.
