**REQUESTED ACTION:** The Zoning Administrator will consider:

1. Pursuant to Section 12.24-W 1, of the Los Angeles Municipal Code, a Conditional Use Permit to allow the sale and dispensing of a full line of alcoholic beverages for on-site consumption in conjunction with a proposed 9,765 square-foot restaurant with 340 seats and live entertainment (unamplified live music) located on the ground floor of a 6-story building. Proposed hours of operation are from 11:30 a.m. to 2:00 a.m., daily.
2. Pursuant to Section 21084 of the California Public Resources Code, adopt the Mitigated Negative Declaration (ENV-2016-0214-MND) for the above reference case.

The purpose of this hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

**Exhaustion of Administrative Remedies:** If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
