REQUESTED ACTION: The Zoning Administrator will consider:

1. Pursuant to Los Angeles Municipal Code Section 14.3.1-E, an Eldercare Facility Unified Permit for the construction, use and maintenance of a four-story, maximum 45-foot in height, approximately 82,700 square-foot, Eldercare Facility with 119 rooms, of which 89 rooms are devoted to Assisted Living (75%) and 30 rooms to Memory Care (25%), accommodating a total 191 beds, with 65 subterranean parking spaces, 6,022 square feet of open space, and 5,863 square feet of amenities/recreational facilities on an approximately [Assessor's parcel size 43,600 sq. ft.– 8,550 sq. ft. Drainage Easement =] 35,050 square-foot buildable parcel, in the (Q)C2-1/(T)RS-1 Zone; and Pursuant to Los Angeles Municipal Code Section 16.05-C,1(b), Site Plan Review for the proposed construction of an Eldercare Facility with more than 50 rooms.

2. Pursuant to Section 21082.1(c)(3) of the California Public Resources Code, adopt the Mitigated Negative Declaration (MND) for the above referenced project.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

Exhaustion Of Administrative Remedies: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.

Advice to Public: The exact time this report will be considered during the meeting is uncertain since there may be several other items on the agenda.
