**REQUESTED ACTION:** The Zoning Administrator will consider:

1. Pursuant to the provisions of Section 12.24 W-1 of the Los Angeles Municipal Codes, a Conditional Use Permit, to allow the sale and dispensing of beer and wine for on-site consumption in conjunction with a proposed approximately 4,317 square-foot restaurant/brewery with 116 seats interior and 16 seats exterior on an approximately 172 square-foot outdoor dining seating area and a 851 square-foot brewery, having hours of operation from 6:00 a.m. to 2:00 a.m. daily, on property located within the [Q]R5-4D zone.
2. Pursuant to Section 21084.1(c)(3) of the California Public Resources Code, adopt the Mitigated Negative Declaration (ENV-2016-0563-MND) for the above referenced project.

The purpose of this hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision

maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

**Exhaustion of Administrative Remedies:** If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
