PROJECT LOCATION: 642, 646 N. Commonwealth Avenue

PROPOSED PROJECT: The construction of twelve (12) small lot homes and the provision of a total of 26 on-site parking spaces. All existing on-site buildings will be demolished.

REQUESTED ACTION: [The Deputy Advisory Agency will consider:](#)

1. Pursuant to the Los Angeles Municipal Code Sections 17.15 and 12.22-C,27, Vesting Tentative Tract Map No. 73859-SL to permit a 12-lot subdivision for 12 new small lot homes, in accordance with the Small Lot Ordinance No. 176,354, and located on an approximately 15,035 square-foot site in the R3-1 Zone;
2. Pursuant to Section 21082.1(c)(3) of the California Public resources Code, adopt the Mitigated Negative Declaration (ENV-2015-3644-MND) for the above referenced project; and
3. Pursuant to Sections 21081.6 and 15097, the adoption of a Mitigation Monitoring Program for ENV-2015-3644-MND.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

EXHAUSTION OF ADMINISTRATIVE REMEDIES: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
