**REQUESTED ACTION:** The Zoning Administrator will consider:

- 1. Pursuant to the provisions of Section 12.27-B of the Los Angeles Municipal Code, a Zone Variance from Section12.19-A.16, to permit the open storage of 46 cargo containers for the storage of furniture, stacking at a maximum height of two containers (approximately 20 feet in height) in conjunction with an existing furniture warehouse business in the M2-1VL Zone.
- 2. Pursuant to Section 21082.1(c)(3) of the California Public Resources Code, adopt the Mitigated Negative Declaration (MND) for the above referenced project.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision

maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

**Exhaustion Of Administrative Remedies:** If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record.
