REQUESTED ACTION: The Zoning Administrator will consider:

- 1. Pursuant to the provisions of Section 12.28 of the Los Angeles Municipal Code, a Zoning Administrator's Adjustment from Section 12.07.01-C,2(b) to allow a tennis court to observe a 0.5-foot side yard at its northerly corner in lieu of the 10-foot side yard required; a Zoning Administrator's Adjustment from Section 12.21-C,1(g) to allow a mandatory 10-foot wall/fence as required by Condition No. 3 of Case No. ZAI 78-100 to be located within the side yard at the same point; and a Zoning Administrator's Adjustment from Condition No. 3 of Case No. ZAI 78-100 to allow a from Condition No. 3 of Case No. ZAI 78-100 to allow a from Condition No. 3 of Case No. ZAI 78-100 to allow a portion of the tennis court to not have a 10-foot wall/fence, all in conjunction with the proposed construction of the tennis court with a personal gym beneath it on a 357,154 square-foot lot in the RE40-1-H Zone.
- 2. Pursuant to Section 21082.1(c)(3) of the California Public Resources Code, adopt the Mitigated Negative Declaration (MND) for the above referenced project.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

Exhaustion Of Administrative Remedies: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
