PROPOSED PROJECT: The project is a request for a Conditional Use to allow hours of operation of 24 hours, daily, in lieu of the otherwise permitted 7:00 a.m. to 11:00 p.m., daily per the Commercial Corner requirements, in conjunction with the operation of a new convenience store (7-Eleven) located in a mini shopping center in the C2-1 Zone.

REQUESTED 1. Pursuant to Los Angeles Municipal Code Section 12.24-W,27, a Conditional Use to allow hours of operation exceeding the otherwise permitted hours of 7:00 a.m. to 11:00 p.m.; and

2. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall, therefore, be exempt from the provisions of CEQA.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.
