



Acrylic to have 1st surface 3/8" Brown (7725-19) vinyl border with 2nd surface diffuser film.
- 2 "Chipotle"- 3" deep stock-Dark Brown (Adobo Brown PMS 4625) coil returns with 1" stock Dark Brown (Adobo Brown PMS 4625) trim-cap. 3/16" Cyro (2447 Milk-White) acrylic faces with White LED illumination.





- **1** "Pepper"- 3" deep stock-Dark Brown (Adobo Brown PMS 4625) coil returns with 1"stock-Dark Brown (Adobo Brown PMS 4625) trim-cap. 1" deep "routed-out" clear acrylic face with 1/2" recessed painted (Adobo Brown PMS 4625) .063 alum. insert and White LED illumination. Acrylic to have 1st surface 3/8" Brown (7725-19) vinyl border with 2nd surface diffuser film.
- 2 "Chipotle"- 3" deep stock-Dark Brown (Adobo Brown PMS 4625) coil returns with 1" stock -Dark Brown (Adobo Brown PMS 4625) trim-cap. 3/16" Cyro (2447 Milk-White) acrylic faces with White LED illumination.
- 3 Above components to be flush mounted on .125 painted alum. Halo cabinets with 3" deep .063 weld on edge returns. 




