REQUESTED ACTION: The Zoning Administrator will consider:

- An Approval of Plans, pursuant to the provisions of Section 12.24-M of the Los Angeles Municipal Code and required by Condition No. 7 of Case No. ZA-2012-2842(CUB) to verify compliance with, and effectiveness of the conditions of approval, relative to the continued off-site sales of a full line of alcoholic beverages in conjunction a convenience market ("Broadway Market & Liquor"), with hours of operation from 7:00 a.m. to 11:00 p.m., daily in the M1-1 Zone.
- 2. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and shall therefore be exempt from the provisions of CEQA.

The purpose of this hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision

maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.
