2. A Director's determination for Mello Act compliance in conjunction with the construction of one new dwelling unit; and

Pursuant to Section 21804 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and shall therefore be exempt from the provisions of CEQA.
