PROJECT LOCATION: 1625 and 1625 ½ North Morton Avenue

PROPOSED PROJECT: A preliminary parcel map for the subdivision of one parcel into three small lots, the demolition of the existing duplex on site, and the development of one-single-family dwelling unit on each lot. The project will provide six (6) parking spaces.

REQUESTED ACTION: The Deputy Advisory Agency shall consider:

1. Based on the whole of the administrative record, the project is **Categorically Exempt** from environmental review pursuant CEQA Guidelines, Section 1, Class 15, and there is no substantial evidence demonstrating that an exception to a categorical exemption pursuant to CEQA Guidelines, Section 15300.2 applies.
2. Pursuant to Section 17.50 of the Los Angeles Municipal Code (LAMC) consideration of

Preliminary Parcel Map AA-2015-1432-PMLA-SL.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

EXHAUSTION OF ADMINISTRATIVE REMEDIES: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.

ADVICE TO PUBLIC: The exact time this report will be considered during the meeting is uncertain since there may be several other items on the agenda.
