REQUESTED ACTION: The Zoning Administrator will consider:

1. Pursuant to Section 12.24-M, of the Los Angeles Municipal Code, approval of plans for the sale and dispensing of a full line of alcoholic beverages in conjunction with the 1,085 square-foot expansion with 39 seats in Building C, previously approved by Case No. ZA 2014-1980(MCUP), for a 9,000 square-foot bar with 256 seats, live entertainment, a DJ, and karaoke, and hours of operation of 10:00 a.m. to 2:00 a.m. daily. The new overall project total of 10,085 square-feet with 295 seats is as follows:
 - 2,760 square-foot ground level bar, with 55 seats
 - 1,673 square-foot ground level outdoor patio, with 110 exterior seats
 - 5,652 square-foot basement level bar with 130 seats

2. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of CEQA.

The purpose of this hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

Exhaustion of Administrative Remedies: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.

Advice to Public: The exact time this report will be considered during the meeting is uncertain since there may be several other items on the agenda.
