PROJECT California State University, Northridge (CSUN) Campus, 18111 Nordhoff Street, Northridge, CA 91330 (see attached map).

PROPOSED PROJECT:

A request by California State University, Northridge to downgrade an approximate 2,000-foot portion of Plummer Street, a pubic street, from Darby Avenue to the west to Lindley Avenue to the east from an Avenue 2 General Plan street designation to a Local Street General Plan street designation. The downgrade to a Local Street designation is necessary to allow the University vacate the public street and incorporate that portion of vacated public street into the University's development plans pursuant to their approved 2006 Master Plan Update – CSUN Envision 2035 dated February 24, 2006. Specifically, the proposed vacated public street is completely within the University boundaries. If vacated, the new land area will be included in the University's internal circulation plans.

REQUESTED ACTION:

- Pursuant to Section 21082.1 of the California Public Resources Code, a Final Environmental Impact Report (SCH# 2005051008) for the above referenced project; and
- 2. Pursuant to Section 11.5.6 of the Municipal Code, a **General Plan Amendment** to downgrade Plummer Street from Darby Avenue to the west to Lindley Avenue to the

east from an Avenue 2 General Plan street designation to a Local Street General Plan street designation.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations. After the hearing, the Hearing Officer will prepare a report, including a recommendation, which will be considered by the City Planning Commission, tentatively scheduled for **Thursday, August 25, 2016**.

**EXHAUSTION OF ADMINISTRATIVE REMEDIES:** If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
