PROPOSED PROJECT:

A Preliminary Parcel Map to split one legal parcel into two legal parcels. The site is currently developed with one commercial building and one warehouse that will be preserved as part of the project. There will be no new construction as part of the project.

REQUESTED ACTION:

The Deputy Advisory Agency will consider:

- 1. Pursuant to the Los Angeles Municipal Code Section 17.53, the subdivision of one parcel into two (2) parcels in the M2-1 Zone; and
- 2. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall, therefore, be exempt from the provisions of CEQA. On May 2, 2016, a Categorical Exemption, Class 15 for Minor Land Divisions (Parcel Maps), was issued for the project.
