**PROJECT LOCATION:** 9421 North Woodman Avenue

**PROPOSED PROJECT:** The demolition of an existing adult daycare facility and the subdivision of one existing lot into twelve (12) small lots for the construction, use, and maintenance of 12 small lot homes in the (T)RD2-1 Zone.

**REQUESTED ACTION:** The Deputy Advisory Agency will consider:

1. Pursuant to Section 17.15 and 12.22-C,27 of the Los Angeles Municipal Code, Vesting Tentative Tract Map 73901-SL to permit a twelve (12)-lot subdivision for twelve (12) small lots with twenty-four (24) residential parking spaces, and twelve (12) guest parking spaces on a 35,378 net square-foot lot in the (T)RD2-1 Zone;
2. Pursuant to Section 21082.1(c)(3) of the California Public Resources Code, adopt

Mitigated Negative Declaration (MND) ENV-2016-479-MND for the above referenced project; and

3. Pursuant to Section 21081.6 of the California Public Resources Code and Section 15097 of the CEQA Guidelines, adopt the Mitigation Monitoring Program for ENV-2016-479-MND.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

**EXHAUSTION OF ADMINISTRATIVE REMEDIES:** If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record.
