**REQUESTED ACTION:** The Zoning Administrator will consider:

- 1. Pursuant to Los Angeles Municipal Code Section 12.24-M and Case No. ZA 2013-4027(MCUP), Approval of Plans to allow the sale and dispensing of beer and wine for on-site consumption, in conjunction with a proposed 3,202 square-foot restaurant with 64 seats and an 808 square-foot patio with 56 seats. Proposed hours of operations are 6:00 a.m. to 12:00 a.m. daily.
- 2. Pursuant to Section 21082.1(c) of the California Public Resources Code, the Certification of Environmental Impact Report, findings, and Statement of Overriding Considerations for ENV-2005-7118-EIR.

The purpose of this hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will
