PROJECT LOCATION: 13641-13647 West Sherman Way

PROPOSED PROJECT: The demolition of an existing fast food establishment and the construction, use, and maintenance of a 92,690 square-foot, mixed-use development with 101 condominium units, 600 square feet ground floor commercial floor area, and 148 on-site parking spaces.

REQUESTED ACTION: The Deputy Advisory Agency will consider:

1. Pursuant to Section 17.03 of the Los Angeles Municipal Code, a Vesting Tentative Tract Map to allow for the subdivision of one (1) lot into 101 residential condominium units and one (1) commercial condominium unit; and

2. Pursuant to Section 21082.1(c)(3) of the California Public Resources Code, adopt the Mitigated Negative Declaration (Case No. ENV-2015-2425-MND) for the above referenced project; and
3. Pursuant to Section 21081.6 of the California Public Resources Code and Section 15097 of the CEQA Guidelines, adopt the Mitigation Monitoring Program for ENV-2015-2425-MND.

The Hearing Officer will consider:

- 1) Pursuant to Section 12.32-F of the Los Angeles Municipal Code, a Zone Change from C1-1VL and R3P-1 to RAS4-1VL;
- 2) Pursuant to Section 12.22-A,25 of the Los Angeles Municipal Code (L.A.M.C.), a 11% Density Bonus (with a set aside of 5%, 5 units, for Very Low Income households); a Density Bonus Parking Incentive (Parking Option 1) to allow 1 parking space for the 0-1 bedroom units and 2 parking spaces for the 2-3 bedroom units; and one (1) Off-Menu Waiver as follows:
 - a. Pursuant to Section 12.22-A,25(g)(3), an Off-Menu Waiver to permit an increase in building height from 3- to 5-stories and 50-feet to 60-feet in the RAS4-1VL Zone governed by Footnote No. 2 in the Van Nuys – North Sherman Oaks Community Plan; and
- 3) Pursuant to Section 16.05 of the L.A.M.C., a Site Plan Review for a development project which creates or results in an increase of 50 or more guest rooms.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

EXHAUSTION OF ADMINISTRATIVE REMEDIES: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
