**PROJECT LOCATION:** 2329 South Purdue Avenue

**PROPOSED PROJECT:** The change of use from office space to auto repair services within the ground floor of an existing one-story, 9,916 square-foot building. The proposal will expand an adjacent automobile repair shop and will not include spray painting; repairs will be limited to include analytical computer assessment of vehicles, tire changes and additional vehicle assessment. Hours of operation are proposed from 7:00 a.m. to 5:30 p.m. Monday-Friday. There will be no modifications to the outside of the building, and no addition of square footage to the building.

**REQUESTED ACTION:** 1. Pursuant to LAMC Section 12.24-W, 4 a Conditional Use to allow an auto repair facility in an existing building in the M2-1 Zone located less than 500 feet from a residential use or an A or R zoned property with hours of operation from 7:00 a.m. to 5:30 p.m. Monday-Friday.

2. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall, therefore, be exempt from the provisions of CEQA (Article III, Section 1 and Class 1, Category 22).

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

**EXHAUSTION OF ADMINISTRATIVE REMEDIES:** If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
