PROJECT LOCATION:

2812, 2814, 2816, 2818 S. Grand Canal; legally described as: TR 6098, Lot 229

PROPOSED PROJECT:

The demolition of a four-unit, multi-family residential structure and two detached garages and the construction of a new three-story, 4,632 square-foot, single-family dwelling with an attached two-car garage; three parking spaces are provided onsite.

REQUESTED ACTION:

- 1. Pursuant to Section 12.20.2 of the Municipal Code, a **Coastal Development Permit** for the demolition of a multi-family residential structure and accessory structures and the construction of a new single-family dwelling, within the dual jurisdiction of the California Coastal Zone.
- 2. Pursuant to Section 11.5.7 of the Municipal Code, a Project Permit Compliance

Review for a project within the Venice Coastal Zone Specific Plan.

- 3. Pursuant to Government Code Sections 65590 and 65590.1 a **Mello Act Compliance Review** for the demolition of four Residential Units and construction of one new Residential Unit in the Coastal Zone.
- 4. Pursuant to Section 21804 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of CEQA.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.
