PROPOSED PROJECT:

Demolition of an existing one-story single-family dwelling and subdivision of two (2) existing parcels into four (4) small lots for the construction, use, and maintenance of four (4) small lot homes in the R3-1 zone. Proposed building height will be 45 feet, four stories, with a roof deck and stair to provide access. Proposed project will provide eight (8) parking spaces onsite.

REQUESTED ACTION:

The Deputy Advisory Agency shall consider:

1. Pursuant to Section 21082.1(c)(3) of the California Public Resources Code, Adoption of the Mitigated Declaration (ENV-2015-2445-MND), for the above referenced project; and

- 2. Adoption of the Mitigation Monitoring Program (MMP) prepared for ENV-2015-2445-MND for the above referenced project; and
- Pursuant to Section 17.50 of the Los Angeles Municipal Code (LAMC), consideration of a Preliminary Parcel Map for a merger and resubdivision of two lots into four small lots to permit the development of four single family dwellings with eight parking spaces.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

EXHAUSTION OF ADMINISTRATIVE REMEDIES: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
