PROJECT LOCATION 380 N. Grenola Street and 391 N. Pintesca Drive, legally described as: TR 9300, Block 138, Lot 6 and 7

PROPOSED PROJECT The demolition of a one-story, 1,290 square-foot, single-family dwelling with a detached garage and the construction of a new two-story, 5,830 square-foot, single-family dwelling with a basement level, an attached three-car garage, associated retaining wall, grading, and a new swimming pool.

REQUESTED ACTION

1. Pursuant to Section 12.20.2 of the Municipal Code, a **Coastal Development Permit** for the demolition of a single-family dwelling and detached garage and the construction of a new single-family dwelling with a basement level, attached garage, retaining wall, grading, and a new swimming pool, within the single-permit jurisdiction of the California Coastal Zone.
2. Pursuant to Section 12.24 X.28 of the Municipal Code, a **Zoning Administrator's Determination** to permit the construction, use and maintenance of a new single-family dwelling fronting on a Hillside Street,

Pintoresca Drive, and a Local Street, Grenola Street, without providing a minimum 20-foot wide roadway adjacent to the property on Pintoresca Drive, as otherwise required by LAMC 12.21 C.10(i)(2).

3. Pursuant to Government Code Sections 65590 and 65590.1 a **Mello Act Compliance Review** for the demolition and new construction of a Residential Unit in the Coastal Zone.
4. Pursuant to Section 21802.1(c)(3) of the California Public Resources Code, adopt the Mitigated Negative Declaration (MND) for the above referenced project.
5. Adopt the Mitigation Monitoring Plan (MMP) for ENV-2016-0166-MND.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

EXHAUSTION OF ADMINISTRATIVE REMEDIES: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
