**REQUESTED ACTION:** The Zoning Administrator will consider:

- 1. Pursuant to LAMC Section 12.24-M, and Condition No. 9 of Case No. ZA 2013-0819 (CUB) Approval of Plans for the continued sale of a full line of alcoholic beverages for on-site consumption in conjunction with and existing 8,777 square-foot adult cabaret and restaurant with 160 indoor seats, with hours of operation 11:00 a.m. to 2:00 a.m. daily.
- 2. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of CEQA.

The purpose of this hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision

maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.
