PROJECT LOCATION: 632 North Radcliffe Avenue, legally described as: Block 23, Lot 6, TR 9300

PROPOSED PROJECT: The proposed project is the construction, use and maintenance of a new second-story addition to an existing, single-story, single-family dwelling with an attached garage to a, in conjunction with the demolition of portions of the existing home and detached garage. The total project area is 3,661 square feet for a total of 4,964 square feet, located within a Coastal Zone.

REQUESTED ACTION:

1. Pursuant to Section 12.20.2 of the Municipal Code, a **Coastal Development Permit** authorizing a 3,661 square-foot two-story addition to an existing 1,303 square-foot, single-story, single-family dwelling with a new attached 365 square-foot two-car garage, with a maximum building height of 28 feet, in conjunction with the demolition of portions of existing home and detached garage, located in the single permit jurisdiction area of the Coastal Zone.

2. Pursuant to Section 21804 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of CEQA. Pursuant to Article III, Section I, Class 3, Category 1 of the City of Los Angeles CEQA Guidelines.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

EXHAUSTION OF ADMINISTRATIVE REMEDIES: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record.
