1. Pursuant to Section 12.20.2 of the Municipal Code, a **Coastal Development Permit** authorizing the construction, use and maintenance of a 1,100 square foot second-story addition to an existing 951 square-foot, single-story, single family residence with a 504 square-foot roof terrace, and a 550 square-foot addition to an existing 544 square-foot detached garage, with a maximum height of 22 feet 6

inches on a 5,200 square-foot lot in the Oakwood Venice Subarea, within the single-permit jurisdiction of the California Coastal Zone.
