**PROPOSED PROJECT:** The proposed project is the retroactive Coastal Development Permit authorizing the subdivision of one lot into two lots previously approved under case AA-2006-6169-PMLA, located within a Coastal Zone.

**REQUESTED ACTION:**

1. Pursuant to Section 12.20.2 of the Municipal Code, a **Coastal Development Permit** authorizing the subdivision of one lot into two lots, which was previously approved under case AA-2006-6169-PMLA, located in the dual permit jurisdiction area of the Coastal Zone.
2. Pursuant to Section 21082.1(c)(3) of the California Public Resources Code, adopt the Mitigated Negative Declaration (MND) for the above referenced project

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The decision maker will consider all the testimony presented at the hearing, written communication received

prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.
