REQUESTED ACTION: The Zoning Administrator will consider:

- 1. A Coastal Development Permit, pursuant to the provisions of Section 12.20.2 of the Los Angeles Municipal Code, to permit the change of use of 24,051 square feet of existing warehouse to office uses, the addition of 7,926 square feet of office use, and renovation to 86,644 square feet of existing office uses, all within the single-jurisdiction area of the California Coastal Zone, and 2) Pursuant to Section 12.24-W,27 of the LAMC, a Conditional Use, to permit deviations from commercial corner establishment/mini-shopping center requirements by allowing 25% building transparency in lieu of 50% transparency as required by Section 12.22-A,23(a)(3), and allowing on-site tandem parking otherwise not permitted by Section 12.22-A,23(a)(4), and a waiver to install a 5-foot wide landscape buffer along the northern property line as required by 12.22-A,23(a)(10).
- 2. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of CEQA.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

Exhaustion Of Administrative Remedies: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.

<u>Advice To Public</u>: The exact time this report will be considered during the meeting is uncertain since there may be several other items on the agenda.
