REQUESTED ACTION: The Zoning Administrator will consider:

- 1. Pursuant to the provisions of Section 12.27 of the Los Angeles Municipal Code, a Zone Variance to allow the construction of a driveway that provides access to a new single family dwelling to have a maximum slope of 23 percent in lieu of the maximum slope of otherwise 20 percent permitted, and to allow the construction of a driveway that provides access to a new single family dwelling that does not meet the Transition Slope requirements designed to the standards established by the Superintendent of Building and Safety required by Code Section 12.21-A,5(g);
- 2. Pursuant to Section 21082.1(c)(3) and Section 15563 of the California Public Resources Code, adopt an Addendum to the Mitigated Negative Declaration (ENV-2015-2637-MND) for the above referenced project.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

Exhaustion Of Administrative Remedies: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.

Advice To Public: The exact time this report will be considered during the meeting is uncertain since there may be several other items on the agenda.
