PROJECT LOCATION: 1888 North Mandeville Canyon Road

REQUESTED ACTION: The Zoning Administrator will consider:

1. Pursuant to the provisions of Section 12.28 of the Municipal Code, a Zoning Administrator's Adjustment granting a 20-foot 11-inch front yard, in lieu of the 25-foot front yard otherwise required by Section 12.07.01, and a structure in the front half of the lots within 55 feet of the front lot line in conjunction with a proposed two-car detached garage; and a pool equipment/trash enclosure with a 0-foot front yard setback.
2. Pursuant to the provisions of Section 12.24.X.7 of the Municipal Code, a Zoning Administrator's Determination granting a maximum 7-foot in height wall and gates within the required front yard in lieu if the maximum 3-1/2-foot high fence otherwise permitted in the RE15 Zone, and a 6-foot in height pool equipment and trash enclosure

within the front and side yard in lieu of the maximum 6-foot allowed in the RE15 Zone and hillside property.

3. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of CEQA.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

EXHAUSTION OF ADMINISTRATIVE REMEDIES: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
