ACTION(S):

The project is to allow the sale and dispensing of a full line of alcoholic beverages for on-site consumption and to allow reduced parking of 23 spaces with 13 parking spaces off-site via a lease for a banquet hall use in an existing two-story, 16,087 square foot Masonic Lodge Building, for members and guests. The banquet hall hours of operation are from 6 a.m. to 2 a.m. daily, with live entertainment and dancing for private events only, with a maximum occupancy load for 1,320 persons.

**REQUESTED** 1. Po

 Pursuant to Los Angeles Municipal Code 12.27, a Zone Variance from LAMC Section 12.11-A to allow the sale and dispensing of a full line of alcoholic beverages for on-site consumption in conjunction with a banquet hall use in the R4 Zone, with hours of operation from 6 a.m. to 2 a.m. daily and a total of 515 seats.

2. Pursuant to Los Angeles Municipal Code 12.27, a Zone Variance from LAMC Section 12.21-A,4(c)(3) and LAMC Section 12.26-E,5 to allow a total of 23 parking spaces in

lieu of 32 parking spaces, and to allow 13 spaces off-site via a lease agreement in lieu of a covenant and agreement otherwise required.

- Pursuant to Section 21082.1(c)(3) of the California Public Resources Code, adopt the Mitigated Negative Declaration ENV2015-1968-MND for the above referenced project; and
- 4. Pursuant to Sections 21081.6 and 15097, the adoption of a Mitigation Monitoring Program for ENV-2015-1968-MND.
