**REQUESTED ACTION:** The Zoning Administrator will consider:

- 1. A Conditional Use, pursuant to the provisions of Section 12.24-W,52 of the Los Angeles Municipal Code, to demolish an existing duplex and the proposed construction of four dwelling units each containing five or more habitable rooms within the Neighborhood Stabilization Overlay (NSO), and 2) Pursuant to the provisions of Section 12.20.3-L, a Certificate of Compatibility, and 3) Pursuant to Section 11.5.7, a Project Permit Compliance for the North University Park Specific Plan.
- 2. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of CEQA

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.
