Pursuant to the provisions of Section 12.28 of the Los Angeles Municipal Code, a Zoning Administrator's Adjustment from Section 12.08.C.2(a) to allow a side yard setback of 3 feet 6 inches, in lieu of the minimum 4 feet 6 inches otherwise required, in conjunction with the construction of a third story addition to the two-story single family dwelling in the R1-1 zone.

The Director of Planning will consider:

- 1. Pursuant to Section 12.20.2 of the Municipal Code, a **Coastal Development Permit** authorizing the remodel of an existing two-story single family dwelling with the addition of approximately 1,034 square feet for a total floor area 3,192 square feet, with a maximum height of 37 feet in the dual-permit jurisdiction of the California Coastal Zone.
- 2. Pursuant to Section 11.5.7 of the Municipal Code, a **Project Permit Compliance Review** for a project within the Venice Coastal Zone Specific Plan.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.
