REQUESTED ACTION: The Zoning Administrator will consider:

- Pursuant to Los Angeles Municipal Code Section 12.24-W,1 a Master Conditional Use Permit for three (3) restaurant/bars and one (1) bar/lounge. Proposed hours of operation are 11:00 a.m. to 1:00 a.m., daily. The total project area is 16,463 square-feet as follows:
 - Sale and dispensing of a full line of alcoholic beverages for on-site consumption in conjunction with:
 - A 4,635 square-foot restaurant/bar with a 2,547 square-foot outdoor patio (166 indoor seats/132 outdoor seats),
 - A 3,591 square-foot restaurant/bar with a 1,497 square-foot outdoor patio (158 indoor seats/82 outdoor seats)
 - A 2,428 square-foot bar/lounge with a 502 square-foot outdoor patio (84 indoor seats/24 outdoor seats)
 - Sale and dispensing of beer and wine for on-site consumption in conjunction with a 965 square-foot restaurant/bar with a 298 square-foot outdoor patio (35 indoor seats/14 outdoor seats).

2. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of CEQA.

The purpose of this hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

Exhaustion of Administrative Remedies: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
