**REQUESTED ACTION:** The Zoning Administrator will consider:

- 1. Pursuant to Section 12.24 X.1 of the Los Angeles Municipal Code, a Zoning Administrator's Determination to permit an Adaptive Reuse Project in the C2 Zone outside of the Downtown Project Area and to grant a yard exception (0-foot northerly side yard in lieu of 6 feet) and a floor area exception (1.62:1 FAR in lieu of 1.5:1 FAR) from the Code. The project is the adaptive reuse of an existing 45-foot 10-inch high office/church/dance hall building into 3,214 square feet of ground-floor restaurant space and nine dwelling units on the second and third floors. Total project size is 11,361 square feet.
- 2. Pursuant to Section 21082.1(c)(3) of the California Public Resources Code, adopt the Mitigated Negative Declaration (MND) for the above referenced project.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

**Exhaustion Of Administrative Remedies:** If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
