PROPOSED PROJECT:

The proposed project involves the demolition of a 3,065 square-foot, one-story, single-family dwelling and the construction of an approximately 5,199 square foot two-story, single-family dwelling with a 2,047 square foot basement, attached 472 square foot two-car garage, and a new swimming pool, with a maximum building height of 29 feet 6 inches, located in the single permit jurisdiction area of the Coastal Zone.

REQUESTED ACTIONS:

1. Pursuant to Section 12.20.2 of the Municipal Code, a **Coastal Development Permit** for the proposed project involves the demolition of a 3,065 square-foot, one-story, single-family dwelling and the construction of a 5,199 square foot two-story, single-family dwelling with a 2,047 square foot basement, attached 472 square foot two-car garage, and a new swimming pool, with a maximum building height of 29.5 feet, located in the single permit jurisdiction area of the Coastal Zone.

2. Pursuant to Government Code Sections 65590 and 65590.1 a **Mello Act Compliance Review** for the demolition and new construction of a Residential Unit in the Coastal Zone.

3. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of the California Environmental Quality Act (CEQA). Pursuant to Article III, Section I, Class 3, Category 1 of the City of Los Angeles CEQA Guidelines.
