PROJECT LOCATION: 14964 W. Camarosa Drive, legally described as: Tract: TR 9377, Block: 5, Lot: 14.

PROPOSED PROJECT: The proposed project involves the demolition of a 3,065 square-foot, one-story, single-family dwelling and the construction of an approximately 5,199 square foot two-story, single-family dwelling with a 2,047 square foot basement, attached 472 square foot two-car garage, and a new swimming pool, with a maximum building height of 29 feet 6 inches, located in the single permit jurisdiction area of the Coastal Zone.

REQUESTED ACTIONS:

1. Pursuant to Section 12.20.2 of the Municipal Code, a **Coastal Development Permit** for the proposed project involves the demolition of a 3,065 square-foot, one-story, single-family dwelling and the construction of a 5,199 square foot two-story, single-family dwelling with a 2,047 square foot basement, attached 472 square foot two-car garage, and a new swimming pool, with a maximum building height of 29.5 feet, located in the single permit jurisdiction area of the Coastal Zone.

2. Pursuant to Government Code Sections 65590 and 65590.1 a **Mello Act Compliance Review** for the demolition and new construction of a Residential Unit in the Coastal Zone.
3. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of the California Environmental Quality Act (CEQA). Pursuant to Article III, Section I, Class 3, Category 1 of the City of Los Angeles CEQA Guidelines.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

EXHAUSTION OF ADMINISTRATIVE REMEDIES: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record.
