REQUESTED ACTION:

- 1. Pursuant to Section 12.20.2 of the Los Angeles Municipal Code, a **Coastal Development Permit** for the proposed demolition of an existing shed and swimming pool with the construction of an approximately 3,310-square-foot, two-story, single-family dwelling with a 400-square-foot, two-car garage, for a maximum building height of 27'-10" feet, located in the dual permit jurisdiction area of the Coastal Zone.
- 2. Pursuant to Government Code Sections 65590 and 65590.1, a Mello Act Compliance Review for the demolition and new construction of a Residential Unit in the Coastal Zone.

3. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of the California Environmental Quality Act (CEQA). Pursuant to Article III, Section I, Class 3, Category 1 of the City of Los Angeles CEQA Guidelines.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.
