REQUESTED ACTION: The Zoning Administrator will consider:

- 1. Pursuant to Los Angeles Municipal Code Section 12.24-X.7, a **Zoning Administrator's Determination** to allow the construction, use and maintenance of an over-in-height fence with a maximum height of 7feet 8-inches in lieu of the six (6)-foot height limit otherwise permitted in the front yard setback, as established by LAMC Section 12.22-C.20(f)(2), in conjunction with the occupancy of a single family residence located on a lot in the RE20 Zone.
- 2. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of the California Environmental Quality Act (CEQA).
